

Rules and regulations for participation and submission of papers for the conference

VI Gdansk Health Days

organised by Student Scientific Association Interdisciplinary Healthcare Management, the Department of Public Health and Social Medicine, and the 2nd Department of Radiology; Medical University of Gdansk



I. General information

1. The 6th Gdansk Health Days Conference (hereinafter referred to as the Conference) and the scientific paper competition (hereinafter referred to as the Competition) are organised by the Students' Scientific Association Interdisciplinary Healthcare Management; Department of Public Health and Social Medicine. of Radiology; Medical University of Gdansk (hereinafter the Organiser).
2. The conference will consist of two days. Four panels are scheduled for the first day. Conference begins with a discussion devoted to endometriosis, followed by an overview of the application of systems thinking in health promotion. The next panels will focus on career paths and new directions in the field of health. The day will conclude with a presentation on mental health and its impact on gut functioning.

The second day includes an English-language panel dedicated to the One Health concept and the idea of Health in All Policies, viewed through the lens of an interdisciplinary approach to 21st-century public health, as well as a session for young researchers.

3. The conference is open to students and doctoral students of medical universities, as well as those interested in the conference's subject, health care professionals, doctoral students and academics, and people who are professionally related to the area of health care after registering in the application form provided for this purpose—*Annex No. 1*.
4. Audience registration is open until **10 April 2026**. Passive participation in the conference is free of charge.
5. The conference will be held on a video-conferencing platform (17th April) and stationary in Gdańsk (16th April). Each pre-registered participant will receive an e-mail link to the meeting.

6. Please state your name when logging in to the platform. If there are insufficient spaces, those not signed in will be removed from the meeting.
7. Participation is subject to acceptance of consent to processing personal data for the conference

II. Conditions for active participation

1. Students and doctoral students can be active participants in the conference if they submit an abstract using the Google form (Appendix 1) by the deadline of **31th March 2026**.
2. Qualified participants are required to pay the conference fee. The fee amount depends on the entry date of the online registration form. - *Appendix 2*.
3. The payment must be made no later than **31th March 2026**, to the following bank account number: *PL 22 1090 1098 0000 0001 5195 6760*
4. The transfer title should follow the format below:

GDZ_31-10008_(title of the presentation)_(surname/s)

Failure to meet this requirement may result in delays in payment verification and, consequently, exclusion from participation in the conference.

5. The organiser allows two, but no more than three, participants to give a speech.
6. If two or more speakers co-present in one paper, please make one payment, specifying the number of speakers in the email with the submitted paper.
7. An abstract and presentation sent after the deadline will not be considered.

III. Submission of entries

1. The topic of the paper should be related to the subjects of the panel presentations, meaning it should address issues such as the microbiome, a holistic approach to healthcare (both medical and holistic), mental health, medical technologies, healthy nutrition, and the One Health concept.
2. The abstract should include the following:
 - a) title;
 - b) authors of the paper with affiliations;
 - c) introduction;
 - d) purpose of the paper;
 - e) research methods;
 - f) results
 - g) conclusions;
 - h) keywords.

3. It should be written in Polish or English, in Times New Roman 12 font, not exceeding 250 words. The text should be justified, spacing 1.5 lines. The title and affiliations do not count towards the maximum word count.
4. The abstract should be submitted in DOC or DOCX format.
5. Figures, graphs and photographs should not be included in the abstract.
6. The Organiser reserves the right to reject the abstract if the regulatory requirements are unmet.
7. The abstract and presentation should be sent to gdanskhealthdays@gumed.edu.pl.
8. If the abstract qualifies, the Organiser will inform of the acceptance of the paper within 7 days of receipt of the email.
9. If the presentation submission deadline is not met, the work will be rejected.
10. By submitting an entry, the authors agree to record the competition speech.

IV. Presentation of Work

1. The author, or one of the authors, presents their work orally on a platform designed for videoconferencing using presentations.
2. Presentations must be uploaded in PPTX or PDF format.
3. The presentation should not exceed 10 minutes.
4. The order in which the presentations are given will be decided by the organisers.
5. The three best presentations will be selected by the Scientific Committee and awarded.

V. Rules for the evaluation of works

1. The Scientific Committee will evaluate the paper, taking into account:
 - a) the merits of the paper;
 - b) the methods used;
 - c) the manner of presentation;
 - d) readability.

VI. Final provisions

1. The entrant agrees to the Organiser's collection and processing of his/her personal data for the purposes of the Conference and the Competition.
2. Sending an application is tantamount to accepting the regulations.
3. The fee paid is non-refundable.
